Invitation to Bid for the Procurement of Internet Connectivity for Voice and Data Communications

1. The Philippine National Police Communications and Electronics Service – Bids and Awards Committee (CES-BAC), through the Certificate of Availability of Funds from the National Expenditure Program (NEP) FY 2018¹ intends to apply the sum tabulated herein being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item hereunder stated:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Philippine National Police Communications and Electronics Service – Bids and Awards Committee (CES-BAC) now invites bids for one (1) lot Internet Connectivity for Voice and Data Communications. Delivery of the Goods is required to be delivered specified in the Terms of Reference after the receipt of Notice to Proceed (NTP). Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *CES BAC Secretariat, Logistics Section, PNP Communications and Electronics Service* and inspect the Bidding Documents at the address given below starting **January 18, 2018** during office hours.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 18, 2018** during office hours from the address below *and upon payment **at the Finance Service, Camp Crame, Quezon City** of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above.*



It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *PNP CES BAC* will hold a Pre-Bid Conference on **January 26, 2017 (10:00 AM, Friday)** at ***CES Social Hall, Ground Floor Commel Bldg., CES HQs, PNP, Camp Crame, Quezon City***, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 5, 2018 (2:00 PM, Monday)**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **February 5, 2018 (2:00 PM, Monday)** at ***CES Social Hall, Ground Floor Commel Bldg., CES HQs, PNP, Camp Crame, Quezon City***. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. In view of the effectivity of the 2016 Revised Implementing Rules and Regulations (RIRR) issued by the Government Procurement and Policy Board (GPPB) and the forthcoming issuance by the GPPB of a new and official Public Bidding Documents template, all words, phrases, clauses, and provisions in this Bidding Documents are understood to be read and interpreted in accordance and in conjunction with the 2016 RIRR. In case of conflict between this Bidding Documents and the 2016 RIRR, the latter shall prevail. All bidders are presumed to have been apprised of the provisions of the 2016 RIRR.
9. The *PNP CES BAC* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
