B. Antenna Slots shall be atop the building with a height of at least 178ft.	
C. Antenna Slots shall be near the PNP Installations of Digital Mobile Radio (DMR) Equipment at Atlanta Tower to reduce cable runs	
D. Payment shall be inclusive of VAT	


Proposal received in excess of the ABC shall be automatically rejected at the opening.
